

CONTRACT

to supply services

Eventlux OÜ (Smile Cleaning), reg.Nº 14123568, hereinafter referred to as

«Executor», represented by a board member Rudolph Bazirov, acting by the Charter, on the one hand, and hereinafter «Client », on the other hand, made an agreement as follows.

Rights and obligations of the parties

1. Client either grants access to the premises for cleaning to Executor or gives keys to Executor. In case of loss of the keys Executor must pay for a new padlock.
2. The Executor undertakes at the direction of the Client undertakes to pay for these services. Cleaning products necessary for cleaning purchased by the Executor independently.
3. The Executor undertakes to provide the services in person. In case of impossibility to provide services the Executor personally has the right to attract a third party for this with the consent of the Client, Remaining responsible to the Client for the actions of a third party.
4. On condition of cleaning on the basis of a long-term contract with a legal or private person, the cost of services is paid by the Client 1 month in advance on the basis of an invoice issued by the Executor. Payment for services by private and legal clients with a one-time order is made at 100% prepayment on the basis of an invoice issued by the Executor no later than 1 day before the start of cleaning.
5. The Client independently chooses the type of cleaning on the site and gets acquainted with the services, included in this type of cleaning. The Executor provides only services related to type of cleaning chosen by the Client. Additional services may be provided. Executor at the request of the Client for an additional fee according to the price list prices.
6. If it is impossible to execute the contract through the fault of the Client, the services are subject to payment in full.
7. In the event that the execution of the contract is impossible due to circumstances for which neither party is responsible, the Client reimburses the Executor actually incurred their expenses (the cost of cleaning products + transportation costs for their acquisition).
8. The Client has the right to refuse to execute this Agreement no later than 24 hours before the booked time for the provision of cleaning services. Upon cancellation of the contract in less than 24 hours, the prepayment made to the Executor in the amount of 100% to the Client is not coming back.
The Client has the right to terminate the long-term contract by notifying the Executor no later than 7 days before the subsequent cleaning in accordance with the schedule.
9. The Executor has the right to take a photo of the Client's premises before and after cleaning for use in case of conflict and for advertising purposes.
10. The Executor has the right to take a photo of the Client's premises before and after cleaning for use in case of conflict and for advertising purposes.

11. Claims for cleaning services The Client has the right to send within 8 hours after the end of cleaning on email. Mail to contact.smilecleaning@gmail.com or phone +37255542697, +3725502860.

12. The Client must not leave extremely valuable items (vases, jewelry and other valuables) in the premises intended for cleaning, they should be removed to the safe or the like If, for any reason, the Client has not done this, he must these items. take a photo and transfer the photo to the Executor. At the end of the cleaning, the Executor also takes a picture of these items to prevent incidents.

13. Parties are responsible for non-performance or improper performance. agreement in accordance with the current legislation of the Republic of Estonia. In case of violation of the contract by one of the parties, the other party has the right to unilaterally terminate it. Disputes under this Agreement shall be resolved by agreement of the Parties, or in court, if settlement cannot be reached.
